2023 ANNUAL MEETING MINUTES

FINANCIAL REPORT

Total dues collected: \$170 per household from 116 homes totaled \$19,720. Expenses included landscaping, utilities, insurance, legal fees, and general maintenance

The checkbook balance at end of 2024 was \$2,143.04.

The savings account balance at end of 2024 was \$47,483.51.

The 2025 budget has planned expenses for landscaping, utilities, events, and maintenance. We were able to keep the annual dues at \$170 per household.

ANNUAL REPORT

We had some board changes in 2024. Bob Roundtree and Chuck Barnett stepped down, with Wes Bain and Wes Elmore stepping up as president and vice president. In February Wes Elmore stepped down. These three men have served our community extremely well for many years. We owe them a great big thank you! Chris Melton joined as Compliance Chairperson and Sabrina Sebastian took over as Landscaping Chairperson. If you are interested in serving on the board to fill the open spot, please notify Wes Bain. We held our board meetings virtually. Any homeowner can attend the board meetings to present and discuss concerns. A visitor does not have voting rights.

Landscaping costs increased due to the unexpected tree removals. We chose not to use our insurance and cause the insurance annual cost to go up. While these were not technically HOA responsibilities, we chose to assist the neighbors and to maintain the neighborhood aesthetics.

Communication with the HOA board can now be accomplished by use of the new email; **hoa@landherrestates.com**. This gives the homeowner and the board a paper trail so that things get completed. Please use the email rather than facebook, texts, or phone calls for official business.

2025 GOALS: We must revise the bylaws and deed restrictions due to out dated items. We will use input from focus groups. The HOA website needs to be updated and integrated with a mobile app for voting, payments, and community discussions. We need to host more community events to encourage engagement and socialization. We are looking into digitize legacy HOA records for better record keeping.
