#### **Old Business:**

- The Board discussed the J-Town Annexation MSD negotiations and Jeffersontown and MSD have suspended the negotiations at this time. This item will be closed at this time.
- Bob Rountree has reached out to Bob Thieneman for HOA Woods at Landherr budget and expenses. The Board will discuss if it is feasible for LEHA to consider merging associations after receiving this information at the November Board meeting.

- The Board voted unanimously to pay ALL LIT UP \$2080.05 for Christmas lights to be installed around Thanksgiving week. Matt is sending check on October 21, 2022. The contract for this company expires 2022.
- The Board will solicit bids for Christmas lights in 2023.
- The Board voted unanimously to pay Full Care \$2236 to install three new lights at south entrance and replenish rocks at both north and south entrance. Full Care will be sending Matt an invoice.
- The Board discussed about adding signature entrance at north entrance. Bob Rountree was going to talk with Bob Thieneman to see if he was still interested in being involved with this project.
- The Board will discuss 2023 Budget and planning the LEHA annual meeting in December 2022.
